1.0 PURPOSE

The attached Policy of the Board of Directors of the Cambria Somerset Authority (CSA) was approved at the meeting of the CSA BOD on November 5, 2015. The attached establishes policy regarding raw water rates and charges to CSA customers.

(Quemahoning, Hinckston Run, South Fork, and Border Dam Water Supply Systems)

RESOLUTIONS

Now, therefore, it is resolved by the Cambria Somerset Authority Board of Directors that rates for the supply of raw water from the Quemahoning, Hinckston Run, South Fork, and Border Dam Systems are hereby modified and amended as follows:

1. Rates and charges shall be in accordance with the schedules attached hereto as EXHIBIT A and EXHIBIT B.
2. Such rates shall be effective for meter readings made on or after January 15, 2016.
3. Existing rates and charges for any and all other portions of the water supply systems of CSA shall remain unchanged (Wilmore system, EXHIBIT B) and in full force and effect as currently adopted, such changes herein set forth being effective only with respect to the Quemahoning, Hinckston Run, South Fork, and Border Dam Water supply Systems (EXHIBIT A).
4. All customers are subject to the applicable rates and charges and shall be subject to a monthly minimum payment (whether any water is drawn or not). The monthly minimum payment shall be equal to the Monthly Rate for the applicable size of meter as set forth under the Minimum Charges and Allowances. Any water not used during any month shall not be taken or used in any other month and the minimum amount shall not accumulate from month to month.
5. All charges and assessments shall be made subject to and in accordance with the rules and regulations of CSA now in effect or as the same may be hereafter amended and modified.
6. All resolutions or parts of resolutions of CSA not in accordance with this resolution are hereby repealed in so far as they affect this resolution.
7. The following will be applicable to all customers with water service for fire protection, as follows:
 - a. Fire Service:
 - i. Fire Hydrants: \$200/Hydrant/year
 - ii. Sprinkler Systems:
 - 2" Fire Service = \$325/year
 - 4" Fire Service = \$700/year
 - 6" Fire Service = \$1,400/year
 - 8" Fire Service = \$2,700/year

NOTE: Any routine usage will be billed in accordance with EXHIBIT A (Industrial Rates) with no monthly allowance. However, there will be no charge for usage during a documented fire emergency.


